The delayed & amended Football Governance Bill, Bradford City Fire 40th Anniversary & very importantly Emergency Medical Protocol at the LNER Stadium were amongst other matters covered, the details of which can be found within our minutes shown below.

Earlier in the day FAB held an internal meeting at which a couple of amendments to our constitution were unanimously agreed regarding our decision making & attendance of members at future meetings. We also thanked Marcus Burton & Jon Clack for their valued contributions to FAB during their time with us. # Minutes of Meeting: FAB Meeting, 26 October 2024

#### 1. Meeting Admin

• **TS** opened the meeting and it was explained a new transcription system utilising Al for recording and drafting minutes was to be trialled.

## **Apologies**

- Apologies were received from TF, who will return to the meetings on 4 January.
- A proposal was discussed to update the constitution: members missing three consecutive meetings may face removal.

# **Member Changes**

- **JC and MB** announced their decision to step down from the group.
  - The board expressed gratitude for their service over four years, highlighting their valuable contributions.
  - Both assured their continued support for the club.

#### **Recruitment for Vacancies**

- TS No response received from the Women's Team regarding vacancies despite repeated follow-ups.
- TS The two replacement roles, as well as the pre-existing vacant space, will be advertised soon.

## **Minutes from Previous Meeting**

• TS - Finalisation of the minutes is pending. Changes will be circulated among the group before uploading to the website.

## 2. Matchday Antisocial Behaviour

- RN Seven complaints were received regarding antisocial behaviour during the Birmingham fixture, significantly higher than usual.
- RT, SK Specific issues included attempted player interference and inadequate crowd control.
- LS Multiple investigations are ongoing, led by the club and police, addressing incidents both inside and outside the stadium.
- LS Six potential criminal incidents were identified: two inside the stadium and four outside.
- RT Why are home fans are treated differently than away fans?
- LS It's not home/away, it is a broader scope, with all 4 stands having to be managed slightly different. The overall stadium management strategy is robustly designed and tested, and not all matters are always obvious to those in the stadium without a holistic view.
- LS The stewards' approach balances enforcement with minimising escalation risks.
- LS A Lincoln City fan was identified as a Birmingham supporter due to a misunderstanding (a joke gone bad), leading to significant tension in the crowd.

- LS Efforts to remove disruptive individuals during the game were met with escalated violence.
- DF The club have been looking at plans to install a barrier across the first row of the Stacey West Stand to address crowds standing in the concourse and improve safety. Plans have been met with resistance from the SGSA (Sports Ground Safety Authority), but this remains ongoing.
- Birmingham fans were in the Legends Lounge on corporate ticket allocations. This led to clashes with home supporters at the same time as the response teams were dealing with the incident in upper 7.
- The club will remind ticket holders of their responsibilities and ground regulations regarding purchasing tickets for away fans in home areas.
- The club is always reviewing matchday procedures, particularly around stewarding and crowd control, and this remains no different. Given the dynamics of the event, the Birmingham City fixtures was overall deemed a success, this was externally verified and supported.
- There is ongoing dialogue with fans regarding fairness in enforcement between home and away supporters.
- The FAB emphasised transparent communication with fans about safety improvements and policy changes.

## 3. Emergency Medical Protocol

- DF The safety team conducted a timely review of emergency protocols ahead of upcoming matches.
- DF Incident response during the match at Upper 7 v Leyton Orient was swift and effective.
- DF Acknowledgement of ongoing training and preparedness by the safety team.

## 4. Bradford Fire 40th Anniversary Commemoration

- DF Collaboration with Bradford City FC and Bradford Council for commemorative activities.
- DF Planned contributions include support for the Burns Unit and remembrance initiatives (e.g., black ribbons, messages on kits).
- DF Discussions ongoing with relevant stakeholders to determine roles and contributions.
- DF Commitment to take a supporting role as directed by the organising entities.

## 5. FA Cup Match Against Chesham

- LS Chesham FC's decision not to segregate crowds, despite recommendations, was noted.
- LS Concerns highlighted about the adequacy of facilities to support segregation. The match has been designated as low-risk by management and authorities.

#### Representation and Inclusion

- JBu Emphasis on continuing efforts to ensure all fan demographics are represented.
- TS Noted progress with EDI (Equality, Diversity, and Inclusion) commitments in football governance reforms.
- TS & RT Positive feedback on the clubs Black History Month event, featuring Jason Lee as a speaker. Recognised as a successful initiative with potential for annual repetition.
