## **Governance & Reporting**

The Club's environmental and sustainability agenda sits within the governance of a Social & Ethics Committee (SEC) which in turn reports to the Club's Executive Board and Board of Directors.

The Executive Officer with formal responsibility for sustainability is Damian Froggatt, Director of Operations & Sustainability.

Membership of the SEC is drawn from a cross-section of the Club's governance and operations including the Chairman, Directors, Senior Executive Officers including the Director of Operations & Sustainability and the Director of Legal & Governance, Supporter Group representation and the Chief Executive Officer for Lincoln City Foundation.

### **Strategic Delivery**

Delivery of the Club's environmental strategy is the responsibility of a cross-club working group (Green Team). The Green Team is responsible for both strategic planning and operational delivery of all environmental and sustainable measures, aligned to the Club's three core principles of investment, innovation and culture.

## **Policy Implementation**

The Green Team is responsible for the development and implementation of policy and for recording and measuring outputs and outcomes. Key areas of implementation include:

## Energy

- Programme of replacement LED
- Commitment to green energy and Solar
- Culture of reducing lighting and heating bills

#### Water

- Reducing water use
- Exploring innovative ways of accessing water from natural sources (waterways, boreholes)
- Recycling initiatives

#### Waste

- Waste management policy, including control measures to manage disposal of cardboard, paper, landfill, single-use plastic, bottles, glass and other
- Recycling plants, reclaim sites, reselling
- Reduce number of waste collections

## Transport

- Working from home policy enabling a hybrid of office- or home-based working
- Removal of all parking on stadium footprint on non-matchdays
- Restriction to number of vehicles on footprint on matchdays
- Incentives and offers to encourage walk-to-work, cycle-to-work, walk or cycle to games
- Installation of EV charging points
- Public transport initiatives

# Food

- Vegan or vegetarian offering on players' menus and in hospitality areas on matchday

### Paper

- Reduce volume of printing and paper used in offices
- Digital technologies and digital workflow systems

## **Procurement**

- Embedding principles of sustainability into supply chains and contract management
- Partnering with local industry which champions sustainability

## Technology

- Innovative use of technology to drive sustainable solutions
