1. Introductions and Overview

- The meeting commenced with a review of the minutes from the previous meeting held on 19

- A heritage project with Lincoln Cathedral to register the IMP and club nickname is under review.
- Plans for a volunteer celebration event before the Bolton game are in progress.

- Recent guests in the lounge included Mick Harford, George Shipley, and Phil Neale.
- The Bolton game will host the Lincoln City Women's team to help promote their cup final.
- Fundraising efforts for the Buddies Dementia Café charity have raised over £1,200 from recent events.
- Upcoming events include a golf day on 11 April and a Bradford City vets match on 10 May.
- Plans are being finalised for participation in the Bradford fire memorial event.
- Consideration of former players' involvement on matchday's and how it could be combined in community programs, including health programmes, youth engagement and crime prevention.
